## ORDER

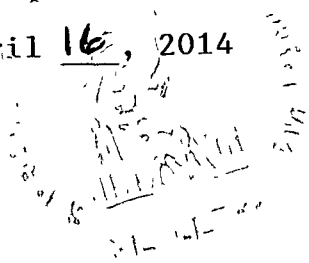
