ORDER

Respondent has filed a motion to dismiss, arguing the underlying order is not immediately appealable. After careful consideration, Respondent's motion is granted and this appeal is dismissed. *See Toler's Cove Homeowners Ass'n, Inc. v. Trident Const. Co., Inc.*, 355 S.C. 605, 611, 586 S.E.2d 581, 584-85 (2003) (noting an order compelling arbitration is not immediately appealable); *Eldridge v. City of Greenwood*, 308 S.C. 125, 127, 417 S.E.2d 532, 534 (1992) (noting orders under Rule 23, SCRPC, are interlocutory and immediately appealable only in certain circumstances).
