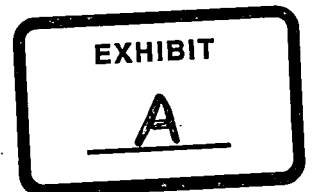


ORDER DENYING MOTION TO RECONSIDER


