This matter comes before the Court on the Motions of Petitioner Tommie Rae Brown and Stephen M. Slotchiver as Guardian *ad Litem* for Petitioner James B. [REDACTED] to sever their respective claims as contemplated by the Court's Administrative Order dated June 13, 2013. Ms. Brown entered a Motion to sever her claims to an omitted spouse's share of the Estate pursuant to S.C. Code Ann. § 62-2-301 and to an elective share of the Estate pursuant to S.C. Code Ann. § 62-2-201 et seq. James B. [REDACTED] entered a Motion to sever his claim seeking a share of the Estate as a pretermitted child pursuant to S.C. Code Ann. § 62-2-302. After considering Petitioners' Motions and supporting Memorandums of Law, it is hereby:

ORDERED that Petitioner Tommie Rae Brown's claim for an omitted spouse's share of the Estate, now part of Case No. 2008-CP-02-1647 pursuant to the Court's Administrative Order filed June 13, 2013, shall be severed from the actions in which it is currently pending;

ORDERED that the Clerk of Court shall assign a new case number to Ms. Brown's claim for an omitted spouse's share; (2013 CP 0202849)

ORDERED that Petitioner Tommie Rae Brown's claim for an elective share, now part of Case No. 2008-CP-02-1647 pursuant to the Court's Administrative Order filed June 13, 2013, shall be severed from the actions in which it is currently pending;

ORDERED that the Clerk of Court shall assign a new case number to Ms. Brown's claim for an elective share; (2013 CP0202850)


ORDERED that Petitioner James B. [REDACTED]'s claim for a pretermitted child share of the Estate, now part of Case No. 2008-CP-02-1647 pursuant to the Court's Administrative Order filed June 13, 2013, shall be severed from the actions in which it is currently pending;

ORDERED that the Clerk of Court shall assign a new case number to Petitioner James B. [REDACTED]'s claim to a pretermitted child's share of the Estate; (2013CP0202851)

ORDERED that each claim severed by this Order shall be deemed a continuation of each respective pending claim for all purposes, and under no circumstances shall any severed claim be treated as having been filed on the date the respective new case numbers are established; and further, it is

ORDERED that the discovery in the severed cases shall proceed on a consolidated basis with each other and also with the claims remaining as part of Case No. 2008-CP-02-1647; and all cases shall be subject to scheduling orders that will be issued by the Court.
