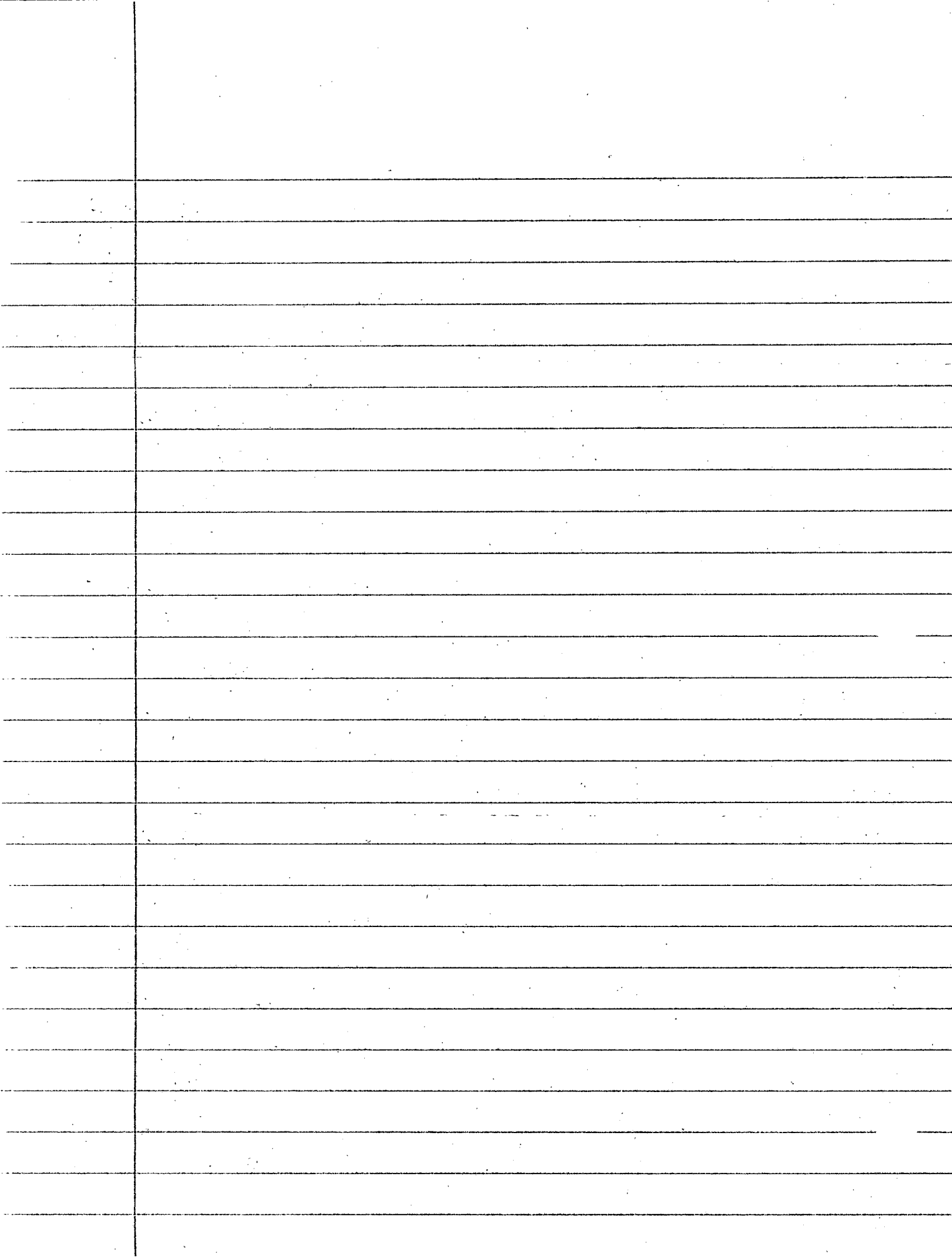

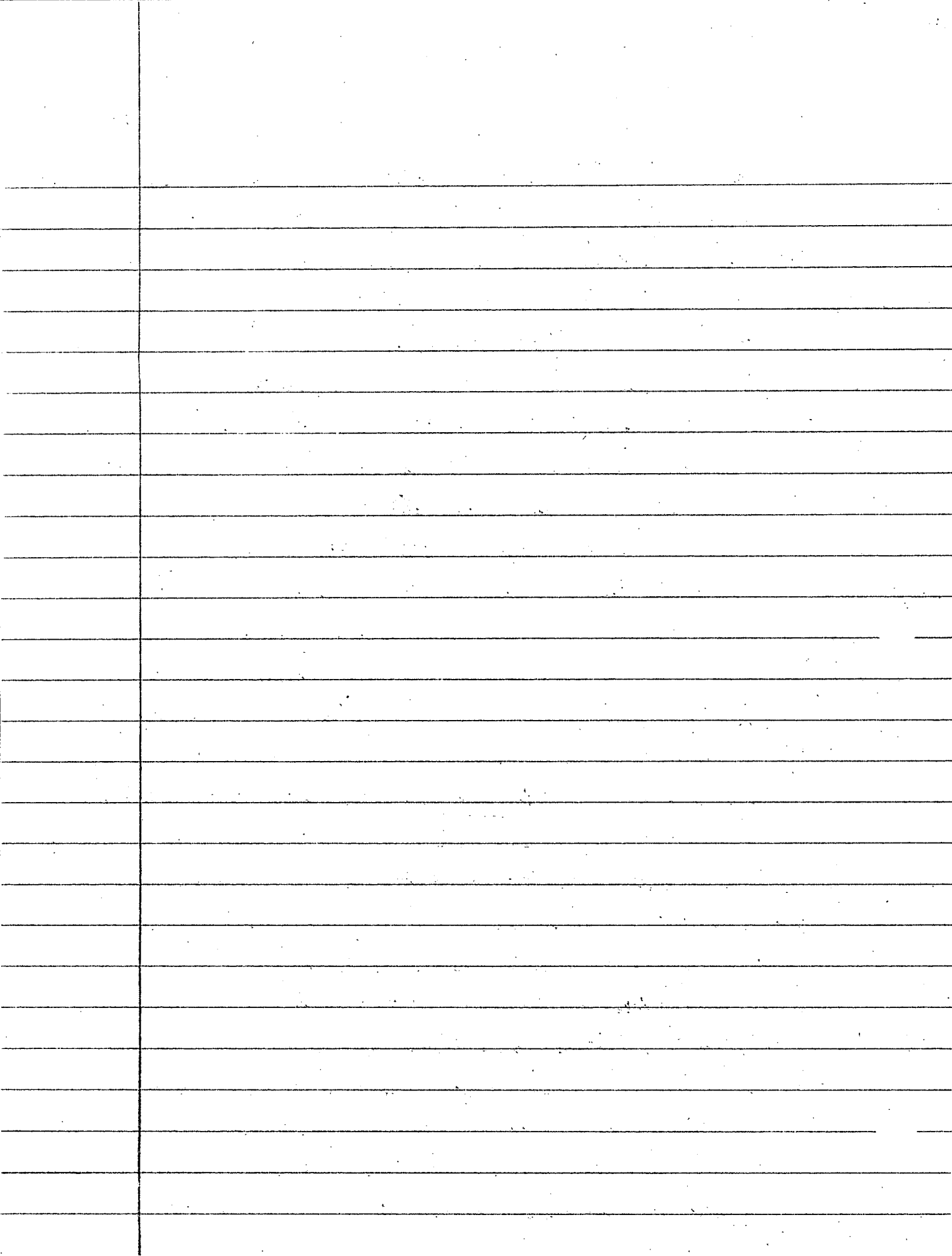
My charges are as follows; - Armed Robbery A/W #: 20916260

attorney did go to two court appearances with me



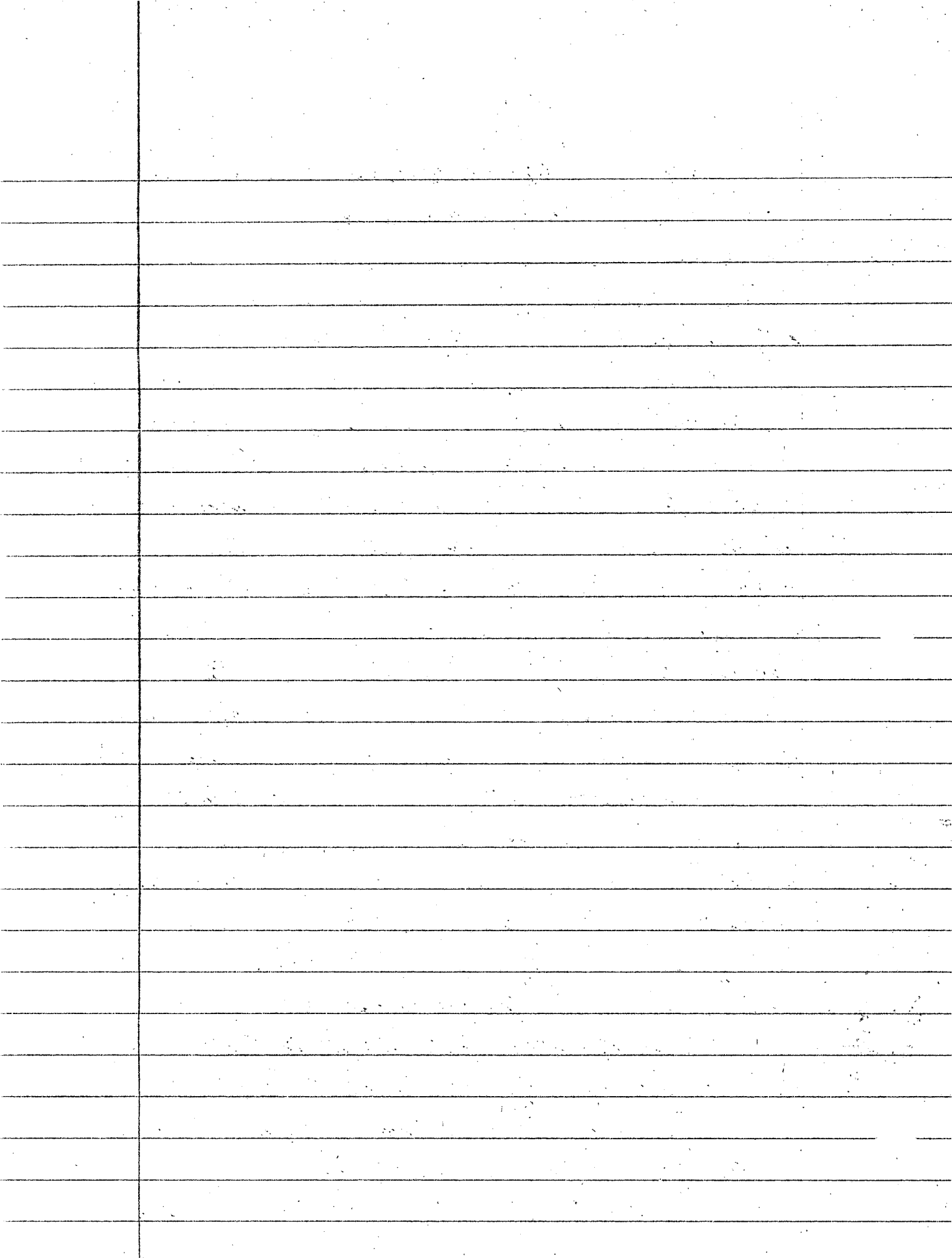
