


Enclosed for filing please find a Notice of Appeal, Proof of Service on the respondent, and a copy of the Sentence Sheet which is to be challenged on appeal.

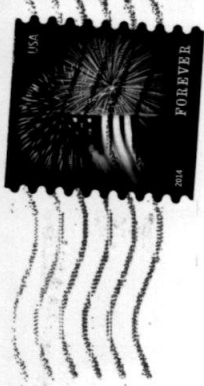
