

Dear Ms. Allen:

I am in receipt of your letter dated April 29, 2014, giving the parties 20 days to file their Final Briefs. 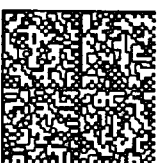
