


This amended Notice of Appeal is per your letter of March 25, 2014 requesting a change in the caption as to the Appellant.

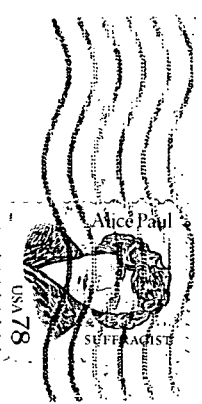
