
1. The petition for writ of certiorari and accompanying appendix in this case are due to be served and filed today.
2. Counsel filed the initial brief of appellant and designation of matter in the case of In the Interest of Samuel B., a Juvenile Under the Age of Seventeen with the Court of Appeals May 7, 2014. Counsel had an oral argument in the case of State v. Victor White in the Court of

Appeals on May 6, 2014. Counsel filed the reply to return to petition for writ of certiorari in the case of State v. Marion Bowman, a death penalty case with this Court on May 5, 2014. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Daniel Willis with the Court of Appeals on May 5, 2014. Counsel filed the reply to return to petition for writ of certiorari in the case of State v. Marion Bowman, a death penalty case with this Court on April 30, 2014. Counsel is working on the potential reconstruction hearing in the case of State v. Sammie Stokes, a death penalty case. Counsel filed the petition for rehearing in the case of State v. Charles Harris with the Court of Appeals on April 17, 2014. Counsel had oral arguments in the cases of State v. Richey Boyd and State v. Tawanda Allen in the Court of Appeals on April 10, 2014. Counsel filed the brief of respondent in the case of State v. Richard Bill Niles Jr. with this Court on April 9, 2014. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Jonathan Mallory with the Court of Appeals on April 4, 2014. Counsel filed the petition for rehearing in the case of State v. Jamaal Hinson with the Court of Appeals with co-counsel Reid Sherard on Thursday, April 3, 2014. Counsel filed the initial brief of appellant in the case of State v. In The Interest of Johnny A., a Juvenile Under the Age of Seventeen with the Court of Appeals on March 26, 2014. Counsel presented at the Best Practices Seminar in Charleston, S.C. on March 24, 2014. Counsel had oral arguments in the cases of State v. Curtis Simms in this Court with co-counsel David Alexander and State v. Mark Peters in the Court of Appeals on March 5, 2014. **Counsel also has extensive administrative duties as the Chief Appellate Defender.**


