MOTION FOR AN EXTENSION OF TIME  
IN WHICH TO FILE THE INITIAL BRIEF OF APPELLANT  
AND DESIGNATION OF MATTER

Counsel for Jimmy Turner respectfully requests an extension of thirty (30) days in which to file the Initial Brief of Appellant and Designation of Matter in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The initial brief of appellant and designation of matter are due to be filed with the Court today. The Court has granted counsel two previous extensions.
2. Counsel for Jimmy Turner respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions

Counsel filed the petition for writ of certiorari and accompanying appendix and the Austin v. State petition for writ of certiorari in the case of Donnie M. Malpass v. State with the Supreme Court on March 27, 2014. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Daniel McNeil v. State with the Supreme Court on March 25, 2014. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Lamar Sequan Brown with this Court on March 24,



5. Counsel for the Attorney General's office consents to this request shown by signature below.




