2. P.D. did not ask solicitor for a recommendation
3. Allowed judge to be influenced by other charges in police report and didn't make clear the fact that I had already been charged for those crimes and completed sentence in relation to those crimes, Therefore they were used in sentencing determination
4. Failed to explain about indictment presentment to grand jury and the ramifications of waiving my rights
5. P.D. did not prep ~~my~~ ^{Defense} ~~character~~ witnesses
6. Met w/ P.D. Once for 15 minutes before trial
