
Gentlemen:





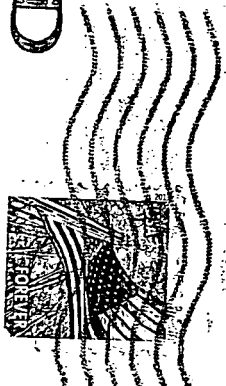
