
Dear Ms. Kitchings:

I now write to you to provide a status update per the request of this Court on this appeal. As you are aware, a reconstruction hearing in this matter was heard in early January of this year and the transcript was promptly ordered. After the 60 days for the delivery of the transcript had expired, the office of Appellate Defense wrote to the court reporter and court administration per the appellate court rules to inquire as to the delivery of the transcript. We received correspondence from the court reporter that she had never received the initial request for the transcript. Accordingly, on March 31, 2014, we sent a second request for transcript to the court reporter.
