

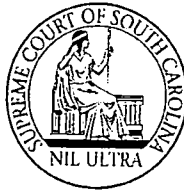

Your letter to Court Administration was forwarded to me for response. You are requesting a transcript from a hearing for December 3, 2013. You may write to the court reporter at the following address:

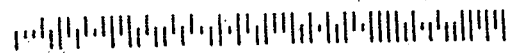
