

NOTICE OF APPEAL

Jeremy Lee Moody appeals his guilty plea and sentence imposed by the Honorable Lee Alford on May 6, 2014. The Appellant pled guilty to Murder-2 counts, Kidnapping-2 counts, Possession of a Firearm or Knife During Commission of a Violent Crime-2 counts, and Burglary 1st Degree and received a sentence of 2 life sentences to run consecutively (for the two Murder charges), and 2 five-year sentences for Possession of a Firearm or Knife during the Commission of a Violent Crime (2 counts) and a Life sentence for the 1st degree Burglary charge to run concurrently. There was no sentence given for Kidnapping charges.


