Ms. Kitchings,

Please allow this correspondence to serve as a formal request for production the disclosure of information relating to the above referenced case.

On October 9, 2013, it would be disclosed to me that this case had been appealed to the Court of Appeals. No information as to case number nor dates were made available to be at that time. J. Marshall Biddle, Esquire, came to visit me in the Special Management Unit (SMU), i.e., lock-up, and informed me that the matter had been dismissed for reasons other than the issues on appeal. At no time since then has Mr. Biddle been responsive to any inquiry for information pertaining to this matter.

On May 14, 2014, my mother had discovered an Initial Brief that had been provided to her, by Mr. Biddle, that had not

been authorized at the time consistent with Rule 11(a), of the South Carolina Rules of Civil Procedures, SCRCP. That is where I found the Case Docket Number that information is now sought on. The Initial Brief was apparently forgotten that had been given to my mother. It seems there is a purpose in not providing me information about this case from other resources. The relevant Docket Number is [#2009-CP-21-2350].


I am requesting that the Clerk of Courts Office, for this South Carolina Court of Appeals provide me with a copy of any and all Orders, Notice of Petition For Rehearing and/or Certiorari, Remittiturs, Opinions (whether published or unpublished), that may have been executed or recorded within this Office. It is my position that this Office is the Administrative Keeper of the Records Office, and should be able to provide me with any records or information that is sought, where none has been provided before.

I have been made to believe that this case is no longer before this Court. That would make it a matter of public record, and this Office is a public body within the meanings and definitions of the South Carolina Freedom of Information Act (FOIA), S.C. Code Ann. §30-4-10 et seq. (2005). I do not believe that I should be placed into a position to invoke the statutory provisions to have these requested matters disclosed to me. I have never been provided a copy of any matter relating to any Brief, record on appeal, order, opinion, remittitur, etc., that is pertinent to these proceedings. I am seeking these matters so that I may be placed into a position to assert my rights in the lower courts and this Court of Appeals.

If I may be of any further assistance to this Office, in these matters, please do not hesitate to contact me. I look forward to hearing from this Office in the very near future. Thank you for this Office's time and attention in these matters.

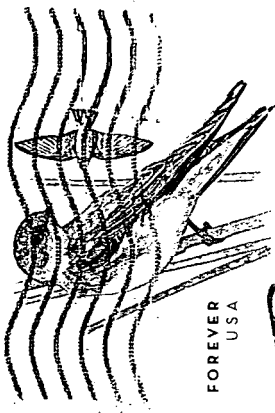

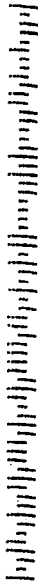
