


Dear Ms. Garrison:

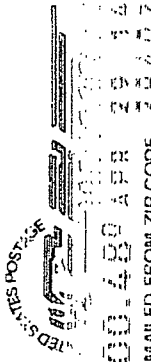
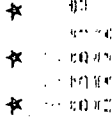
