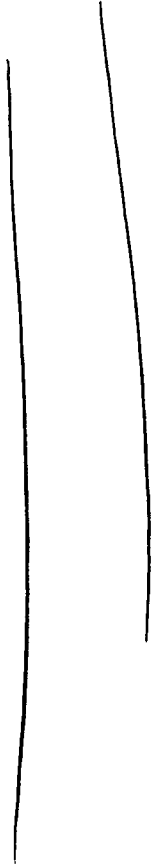

This unit responded to the above incident location concerning a burglary. Upon arrival, I spoke to the complainant who stated that he arrived at the location around 0630 this morning. When he arrived, he noticed the victim's big screen TV on the front porch, so he notified the victim. The victim stated that at approximately 0130 hrs his alarm company notified him that the alarm was going off at the incident location. Deputy Grimes, C-132, responded however the driveway was blocked by a chain, so no contact was made with the residence. The victim stated that the unknown subject was caught by the exterior camera walking around the residence at 0104 hrs. The footage shows the subject walking around and shining a flashlight into the residence. When he noticed the camera, he destroyed one by knocking it off the screen and simply realigned the others. The subject then entered the residence and did remove. I HAVE RECEIVED A COPY OF THE 1997 VICTIMS AND WITNESS SERVICES STATUTE.

The big screen television. Once the subject was at the front porch, he left the table and departed the scene. The exterior video cameras captured the incident until he realigned them. The scene was processed and I was able to obtain a partial print from a chair, which was under the destroyed camera. The front door to the residence was also damaged, value of \$1,000.00. I was unable to locate prints on any items. I did photograph a foot wear impression left on the porch covered porch. The subject on the video appeared to be a black male wearing a pair of Coveralls, possibly blue, and a Camo hat. The victim advised that he would place a copy of the video to this deputy to be placed into evidence. The print left and the photograph taken will also be placed into evidence. The victim was provided with a victim form. The video camera is valued at \$1,000.
