FINAL ORDER

This matter comes before me on January 6, 2014 upon the filing of a Summons and Complaint by the Plaintiff on ~~March~~ ^{April 2}, 2012 for breach of contract, detrimental reliance and conversion. Subsequently, the Defendant timely answered and counterclaim for breach of contract. Present at the hearing was Plaintiff Lydia Miller, her attorney, Joshua Koger, Jr., the Defendants and their attorney, William F. Gorski. After hearing the arguments and reviewing the exhibits, the Court makes the following findings of facts and conclusions of law.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. The Court finds that a valid contract existed between Plaintiff Miller and Defendant Fields and, thus, the Court awards Plaintiff Miller the sum of Twelve Dollars (12,000.00)
2. The Court finds that Plaintiff Miller paid Twelve Thousands Dollars (\$12,000.00) to Defendant Fields as a down payment toward a purchase of a mobile home.

3. The Court finds that Defendant Fields represented to Plaintiff Miller that the mobile home would be in a livable condition upon the arrival of Plaintiff Miller in August of 2011.

4. The Court finds that the mobile home was not in livable condition upon the arrival of Plaintiff Miller in August of 2011;

5. The Court finds that Plaintiff Miller did not receive from Defendant Fields what was bargained in return for the given consideration by Plaintiff Miller and that the consideration should be returned to Plaintiff Miller.

6. The Courts finds that no other claims and damages by Plaintiff Miller were proven to the Court.

7. That Courts finds that incidental and/or consequential damages are costs that should be borne by the respective parties.

8. The Court finds the Defendant White should be dismissed from this action as she is not a proper party.

9. The Courts finds that Defendant Knight did not appear at this hearing and thus, she did not pursue her claim of conversion and thus, her claim should be dismissed.

10. This Court has jurisdiction over the parties and subject matter of this action.

THEREFORE, IT IS HEREBY ORDERED:

A. Plaintiff Miller is awarded Twelve Thousand Dollars (\$12,000.00) on a breach of contract claim from Defendant Fields;


B. Defendant Fields is to pay this sum to Plaintiff Miller within 15 days of the signing and filing of this Order.

C. Defendant White is dismissed from this action;

D. The claim of Plaintiff Knight is dismissed from this action;

AND IT IS SO ORDERED.
