

ACCORDING TO APPELLANT'S RECORDS, PLEASE NOTE THE FOLLOWING: NOVEMBER 8, 2013, THE SOUTH CAROLINA COURT OF APPEALS ISSUED AN ORDER GRANTING APPELLANT THE RIGHT TO PROCEED INFORMA PAUPERIS ON APPEAL FROM THE ADMINISTRATIVE LAW COURT ORDERS. NOVEMBER 21, 2013, APPELLANT SERVED HIS APPELLANT'S INITIAL BRIEF AND DESIGNATION OF MATTER TO BE INCLUDED IN THE RECORD ON APPEAL, WITH PROOF OF SERVICE IN REFERENCE TO ABOVE MATTER. THE ONLY PROPER MEANS APPELLANT HAD FOR RESPONDING TO RESPONDENT'S INITIAL BRIEF, CONCERNING

ABOVE MATTERS ON APPEAL WAS TO FILE A REPLY BRIEF. APPELLANT'S REPLY WAS SERVED AND FILED TO BE INTENDED FOR THIS COURT TO ACCEPT AS A VEHICLE FOR RESPONDING TO RESPONDENT'S ASSERTION ASKING THE COURT ON APPEAL TO REVIEW THE MATTER RAISED IN THE CASE.

AND ACCORDINGLY TO THE APPELLANT'S FILES, DECEMBER 19, 2013, THE RECORD ON APPEAL AND PROOF OF SERVICES FROM APPELLANT WAS INCLUDED, PLUS APPELLANT'S COPY WAS RETURNED. SO THERE COULD NOT BE A FAILURE BY APPELLANT TO COMPLY WITH SOUTH CAROLINA APPELLATE COURT RULE. DO APPELLANT NEED TO REVISE THE REFERENCES OF THE RECORD? YOUR ASSISTANCE IS GREATLY NEEDED TO REVIEW THE FILINGS ON ABOVE APPELLATE CASE AND ISSUE A ORDER ON THE MECHANISM THROUGH WHICH TO PROPERLY GUIDE THIS APPEAL IN REFERENCED TO ABOVE APPELLATE CASE.

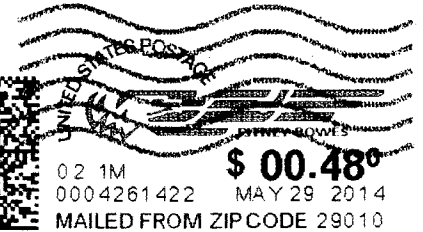
