24 A. I don't recall.

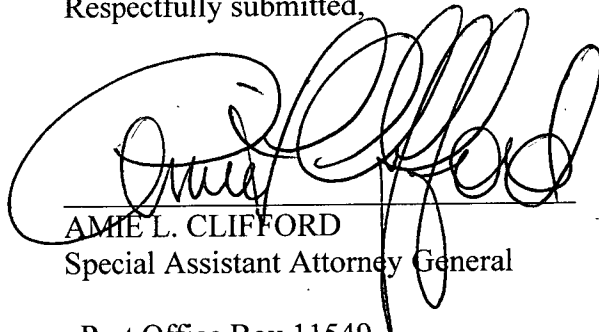
