
**AMENDED NOTICE OF APPEAL**

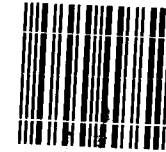
