
MOTION TO REINSTATE

The above-captioned case was dismissed by the Court for failure to timely file and serve the Appellant's final brief and record on appeal. The Appellant hereby moves to reinstate the appeal. Counsel has resolved those issues, however, and is prepared to immediately correct the deficiency and serve the required documents.

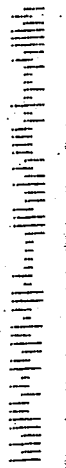


