
Appellants filed the Record on Appeal on or about April 22, 2014, and served the Record on Appeal on respondent on May 9, 2014. By rule, respondent's final brief is therefore due May 29, 2014. However, in preparation, respondent discovered the following:

Appellants filed their Designation of Matter to Be Included in the Record on Appeal on or about November 25, 2013. Appellants' designation included the item "Dick's [sic] Form 50, dated 11/19/12 [sic](actually filed by Fletcher and dated 11/19/12)." This document does not appear in the Record on Appeal prepared by appellants and filed on or about April 22, 2014. Since it was included in the Designation and since respondent refers to this item at several points in her Brief of Respondent, this document must necessarily be included in the Record on Appeal.

Also, respondent filed her Designation of Matter to Be Included in the Record on Appeal on March 28, 2014. Respondent's designation included the item "Dick's appellants' brief to FC, dated 5/17/13." This document does not appear in the Record on Appeal prepared by appellants and filed on or about April 22, 2014. Since it was included in the Designation and since respondent refers to this item in her Brief of Respondent, this document must necessarily be included in the Record on Appeal.

WHEREFORE, respondent Fletcher hereby moves the Court for an Order requiring appellant Dick's Sporting Goods to supplement the Record on Appeal to include the above items. Respondent also prays for an Order staying the filing requirements for the Brief of Respondent until such time as the Record on Appeal is complete and correct.


