


PURSUANT TO RULE 240(e), SCACR, THE RESPONDENT HEREBY PROVIDES ITS RETURN IN OPPOSITION TO APPELLANT'S MOTION TO REINSTATE APPEAL PURSUANT TO RULE 260(a), SCACR.

1. Appellant filed her Notice of Appeal in this matter on June 24, 2013.
2. As provided by the return of Respondent LaSalle Bank National Association to the Appellant's Motion to Reinstate Appeal, the transcript of the hearing held before the Honorable Diane Goodstein on November 14, 2012 was provided to Appellant on January 28, 2014 and a copy of the letter wherein said transcript was provided to Appellant was mailed to this Respondent.
3. By letter dated March 19, 2014, this Court notified and directed Appellant to file and serve her initial brief and designation of matter within ten (10) days of said letter.
4. Appellant failed to file and serve her initial brief and designation of matter as directed by this Court.
5. By order filed May 19, 2014, this Court dismissed this appeal as a result of Appellant's failure to comply with the Court's direction.
6. On May 22, 2014, Appellant filed a Motion to Reinstate Appeal alleging she was under the impression that her appeal was being held in suspense based on a letter from this Court on April 16, 2014. *See* App. Motion ¶¶ 1-2.
7. Appellant's initial brief and designation of matter remain outstanding.
8. This Respondent hereby joins and supports the assertions contained in Respondent LaSalle Bank National Association's return to Appellant's Motion to Reinstate Appeal dated May 27, 2014.

For the reasons stated, Respondent respectfully requests that this Court DENY Appellant's Motion to Reinstate Appeal where Appellant has failed to file and serve her initial brief and designation of matter pursuant to Rules 240 and 208(a), SCACR and Appellant has failed to comply with this Court's order dated March 19, 2014.


