
To cover the cost of requesting this extension, my firm's check in the amount of \$25.00 is enclosed.

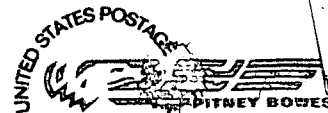
