Thanks again for your cooperation. Please advise me of your decision at your earliest convenience. If you have any questions concerning this matter, please do not hesitate to contact me.

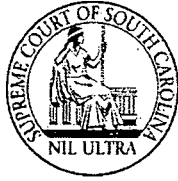

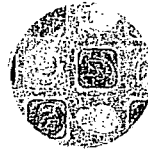
