
I am in receipt of your letter dated February 27, 2014 requesting the above-referenced transcript. I have reviewed my records and estimate that your transcript will be 125 pages. Based on the current rate of \$3.25 per page, the cost is estimated to be around \$406.25, plus shipping. Under our rules, I have 60 days in which to complete the transcript.

Upon receipt of a certified check or money order (no personal checks, please) for \$200.00 as a down payment, the 60 days begin. If I have under-estimated the number of pages, you will be notified prior to delivery of the transcript of the balance due. If I have over-estimated the number of pages, you will be refunded the overpayment. When the transcript is complete, I will then notify you of the remaining balance due. Once the balance is paid, the transcript will be sent within three business days.

In the event I need an extension of time to complete the transcript, I will request an extension from Court Administration. You will be notified if the extension is granted. I do, however, estimate to have this completed within three weeks according to my workload.

I have received your request for the status of the transcript in the matter of Kevin Nixon requested by Mr. Charles Brooks on February 27, 2014.
