
Dear Mr. Cockrell:

Thank you for your recent request for a transcript regarding the above case. I will be happy to provide that for you; however, advanced payment is required.

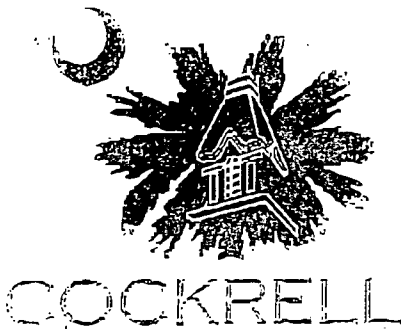
I estimate the cost to be \$66.80, which includes postage. Please note: Under our rules, I have 60 days from date of receipt of payment in which to prepare the transcript.

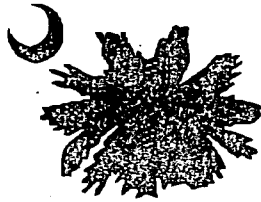
