**COUNT ONE - CRIMINAL SEXUAL CONDUCT 3<sup>RD</sup> DEGREE**


That in Sumter County, South Carolina, on or about 2012-09-19, the Defendant, JAMES GREGORY YOUNGER, did commit a sexual battery upon the victim, Kimberly Baker, with knowledge or reason to have knowledge that the victim was mentally defective, mentally incapacitated or physically helpless where aggravated force or aggravated coercion was not used, to wit: have anal sex against her consent; all in violation of Section 16-03-654, Code of Laws of South Carolina, (1976, as amended).

**COUNT TWO - ASSAULT AND BATTERY 2<sup>ND</sup> DEGREE**

That James Gregory Younger did in Sumter on or about 2012-09-19, violate Section 16-3-600(D)(1) of the Code of Laws of South Carolina (1976), as amended, in that he did unlawfully injure another person, or offer or attempt to injure another person with the present ability to do so and the act involves the nonconsensual touching of the private parts of an adult, either under or above clothing.

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.




