MEMORANDUM IN SUPPORT


On May 17, 2012 the Honorable Roger M. Young signed an Order stating that the Judgment in the Circuit Court is against The Law Office of Jay A. Mullinax, LLC and Jay A. Mullinax, individually. During trial on April 18-20, 2012, the judgment against “Jay A. Mullinax, individually” was dismissed and he should not have been included on the Order (Form 4 – Judgment In A Civil Case).


