NOTICE OF APPEAL FROM GUILTY PLEA
AND EXPLANATION OF BASIS FOR APPEAL

Eddie Mack Stewart plead guilty on June 12th, 2014, in Aiken County. The Honorable Doyet A. Early, III, imposed sentences as follows:

2013-GS-02-0230	Burglary 1 st	25 years
2013-GS-02-0231	Grand Larceny > \$10,000	10 years concurrent

Stewart hereby gives notice of the appeal of his convictions and sentences.

Written explanation of appeal from guilty plea:

Stewart pled guilty pursuant to an agreement for a recommendation of 25 years on the Burglary 1st, with a concurrent sentence on the Grand Larceny. The recommended sentence was imposed. Stewart submits on appeal that his plea was involuntary, the denial of his motion to withdraw his plea was an abuse of discretion, and his plea was based on advice from counsel which constituted ineffective assistance of counsel.

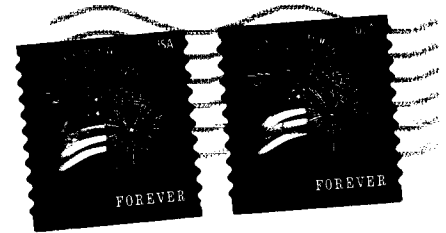
