I have received a letter from your office dated May 29<sup>th</sup> regarding the above-captioned case. After checking with my office records, the last time I represented Robert Prang was in 2008. I have not represented him on any matters since then, nor have I filed any appeals on his behalf. My representation of Mr. Prang ended on October of 2008.
