I am submitting my Final Brief as well as a revised Record on Appeal. The week that I had to prepare and to file the fifteen copies of my Final Brief along with the Record on Appeal, I received a letter from Mr. Thoensen's office it indicated that my Record on Appeal was not paginated properly. My understanding of the pagination was, from what I understand now, incorrect. When reading the Form from the South Carolina web site I thought that I was supposed to list by index the items to be included in the Record on Appeal, not knowing that I was to change the numbers on the actual original documents. I thought that would be considered altering the document. I revisited the letter that was sent to me from the court and it said to number each page consecutively. these procedures begin in December. My new insurance began in January so I had to wait for new authorizations. I think that the weekly anesthesia and constant pain medication may have impaired my abilities. I have attached a brief list of the surgery dates. I have enclosed a copy of the form that I found online also as supporting documentation. .
