MOTION FOR COSTS

Pursuant to Rule 222, SCACR, Sara Dawkins requests that the costs of this appeal be taxed against Union Hospital District (aka) Wallace Thomson Hospital, who was the Respondent. The Court reversed the circuit court's decision in an opinion filed April 9, 2014. The Court issued the remittitur in the case June 11, 2014.

Rule 222(a) provides that when a judgement is reversed, costs shall be taxed against the respondent unless the court orders otherwise. Because the Court has not ordered otherwise and the parties have not agreed otherwise, the rule provides the Court should award costs to Appellant.

In accordance with the instructions of Rule 222(d), an itemized statement of costs is attached to this motion.




