


MEMORANDUM



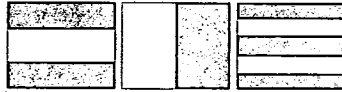
