I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

Based on the investigation by the Orangeburg County Sheriff's Office one Karen Diane Gibson did commit the crime of Unlawful Conduct Towards a Child section 63-5-70 of the South Carolina Code of Laws that on January 15, 2014 the defendant Karen Diane Gibson did throw a glass cup hitting the victim on her right arm causing a 1 1/2 cut, after having smoked crack. There is a previous history of abuse by the defendant. The victim was EPC and placed in the custody of DSS. This incident occurred in the County of Orangeburg, State of South Carolina.
