
MOTION TO STAY APPEAL

Pursuant to Rule 240, SCACR, Appellant, with the consent of the Respondent, hereby moves to hold this appeal in abeyance to allow a supplemental order to be entered by the court below. This matter was heard on appeal by the Honorable Deadra L. Jefferson on March 17, 2014. Following the hearing, Judge Jefferson entered an order dismissing the appeal on April 15, 2014. This appeal followed.

Judge Jefferson subsequently realized that her order contained a factual error that could impact the resolution of this appeal. She approached the parties regarding an amended order that would correct this error. The parties agreed with Judge Jefferson's determination and have consented to the entry of an amended order.

The parties therefore desire that this appeal be held in abeyance to permit Judge Jefferson to enter a supplemental order which corrects the deficiency. A copy of the original order was previously filed with the Court of Appeals.


