There will likely be an overflow crowd at the Supreme Court hearing June 24 in the Bobby Harrell case. Clerk Dan Shearouse has said reporters wanting to use tape recorders in the hearing must file a request with him. The Court is planning to allow two still cameras – one for AP and one pool newspaper photographer. A lottery is likely to be needed to select the pool photographer, who must agree to share a few photos with others via the SCNewsExchange. If you want to shoot the hearing as the pool photographer, email your request to Bill Rogers at SCPA no later than June 17. You must have quality digital equipment and appropriate lenses to be in the pool.

Cell phone cameras may not be used in the courtroom, Shearouse said.

Photographers should wear a coat and tie, or equivalent professional female attire.

He also advised arriving early. You must pass through security and there may be a line. There will be no specific seating for the press. Cell phones must be turned off, so no Tweeting.
