
**PETITION FOR EXTENSION OF TIME TO FILE THE PETITION FOR WRIT

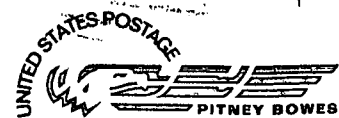
