MOTION FOR EXTENSION


It is respectfully requested that the undersigned be granted an extension to file the Initial Reply Brief until Monday, June 30,2014 upon the following grounds:

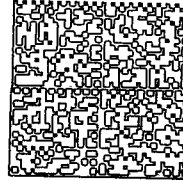
