MOTION TO FILE A THIRD SUPPLEMENTAL APPENDIX

The purpose of filing the supplemental appendix is to provide the Court with applicant's proposed order granting relief that was provided to the PCR court. Undersigned counsel was unaware of the existence of this proposed order until recently when Respondent advised counsel of such and provided a copy. Additionally, Respondent requested a supplemental appendix be filed to provide this Court with the proposed order. In light of the requirement found Rule 243(f)(1), SCACR, that the appendix contain the entire lower court record, undersigned counsel has no basis to object to the inclusion of applicant's proposed order granting relief.


On March 28, 2014, undersigned counsel filed a petition for writ of certiorari and accompanying appendix in the above-referenced case. Petitioner was sentenced to death on September 11, 2008. He filed an application for post-conviction relief, which proceeded to an

evidentiary hearing on October 1, 2012. The PCR court denied the application, and Petitioner now appeals that decision.

When filing the petition, undersigned counsel provided this Court with an appendix that included Respondent's proposed order. Indeed, one of Petitioner's allegations in his petition for writ of certiorari in support of granting him relief concerns the PCR court's wholesale adoption of Respondent's order. Therefore, provision of applicant's proposed order granting relief appears relevant to this Court's decision on the petition.

Therefore, undersigned counsel asks this Court to accept the third supplemental appendix to comply with Rule 243(f)(1), SCACR, and Respondent's request that the applicant's proposed order granting relief be provided.


