MOTION FOR AN EXTENSION OF TIME

the order in which counsel attempts to manage his caseload, counsel hopes that no further extension requests will be required.



On May 28, 2014, counsel filed a petition for writ of certiorari and accompanying appendix in Tony Moore. v. State with this Court. On May 22, 2014, counsel filed a petition for writ of certiorari and accompanying appendix in Tony Moore v. State with this Court. On May 20, 2014, counsel filed a petition for writ of certiorari to the Court of Appeals and accompanying appendix in State v. Antonio Scott with this Court. On April 24, 2014, counsel filed a petition for writ of certiorari and accompanying appendix in Roy Johnson, Jr. v. State with this Court. On April 18, 2014, counsel filed a petition for writ of certiorari and accompanying appendix in Maurice Shaundell Hope v. State with this Court. On April 17, 2014, counsel filed a petition for writ of certiorari and accompanying appendix in Taveio Boston v. State with this Court.

4. Counsel makes this request in good faith and not for purpose of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.

5. Counsel for the Attorney General's office has been informed of this request.

WHEREFORE, the undersigned counsel would respectfully request a thirty day extension in which to file the petition for writ of certiorari in this case based upon the above exigent circumstances.
