

NOTICE OF CROSS APPEAL

Estate of Hugh S. Thompson (“Respondent-Appellant”) hereby appeals the attached Order of the Honorable J. Michael Baxley, Circuit Court Judge, dated April 15, 2014 and filed April 21, 2014. Respondent-Appellant received written notice of the entry of the Order on April 18, 2014. After the Honorable Paul M. Burch, Circuit Court Judge denied the Appellant-Respondent’s motion to alter or amend Judge Baxley’s decision (by Judge Burch’s Order filed May 14, 2014), Respondent-Appellant subsequently received a copy of the Appellant-Respondent’s Notice of Intent to Appeal on June 12, 2014. Pursuant to Rule 203(c), SCACR, Respondent-Appellant files this notice of their intention to pursue a cross-appeal within five (5) days of receipt of the Appellant-Respondent’s original Notice of Intent to Appeal.


