Please permit this correspondence to serve as my second formal request for production of documents in the above referenced cases.



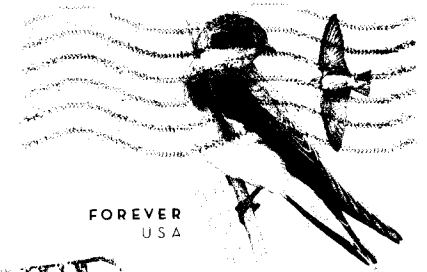
