


I am in receipt of your letter dated March 10, 2014 requesting the above-referenced transcript. I have reviewed my records and ESTIMATE that your transcript will be 320 pages for the days I covered. That was the week of the bad ice storm and I had to cover Ms. Keisha Reed on the days of February 13th and 14th. Based on the current rate of \$3.25 per page, the cost is estimated to be around \$1,040.00, plus shipping.

Under our rules, I have 60 days in which to complete the transcript. It is my practice that I collect a down payment before starting such a voluminous transcript for half the estimated cost. Upon receipt of a certified check or money order or firm check (no personal checks, please) for \$500.00 as a down payment, the 60 days begin. When the transcript is complete, I will then notify you of the remaining balance due. Once the balance is paid, the transcript will be printed and sent within three business days, and if you wish I can also Email it to you so that you can have it immediately while you wait on the hard copy.

In the event I need an extension of time to complete the transcript, I will request an extension from Court Administration. You will be notified if the extension is granted.
