And due towards the copy restrictions here at Lee C.I., Appellant is only allowed to make (3) copies of each legal material per week and no handwritten materials are allowed to be copied unless they were clock-dated and stamped by a clerk's office first.

Therefore, Appellant would pray upon an order to be allowed to file the Belated Record on Appeal upon Opposing Counsel with an Enlargement of Time to do so. Also granting any such other and further relief as the Court may deem just and proper.
