Appellant's Request For Injunctive Relief and Extension of Time

---

Appellant has over 30 cases pending in South Carolina. Appellant was transferred to Lieber C.I. on May 27<sup>th</sup> 2014. Appellant has constantly notified the General Counsel's office through Request to Staff Member and the S.C. DC Kiosk computer system, that he is not receiving the needed amount of legal supplies to adequately fight his cases. Angela Hardin, Danya Haile, and MR. Christopher Florian have notified MRS. Percy of the Lieber C.I. business office to provide me with legal supplies adequately.

Appellant contends since May 27<sup>th</sup> 2014 he has received over 100 pieces of legal mail. Yet MRS. Percy has only given him legal supplies twice, (5) envelopes, 1 per, and 20 sheets of paper, the second time (10) envelopes, 20 sheets of paper and 2 Big Brown envelopes.

On June 23<sup>rd</sup> 2014 I notified General Counsel MR. Christopher Florian in person at the Allendale County Courthouse that I have not received any legal supplies since June 6<sup>th</sup> 2014. He assured me he would look into this. On June 24<sup>th</sup> 2014 MRS. Haile and MRS. Hardin contacted the business office and they still refused to send me legal supplies. MRS. Melinda Burch called the business office on June 24<sup>th</sup> 2014 and spoke with MRS. Percy. MRS. Percy advised MRS. Burch she had been gone for two weeks and the
