EXTENSION OF TIME





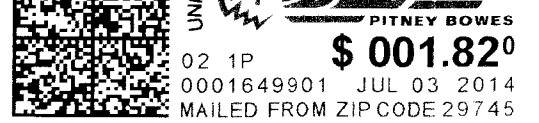
