
The brief of appellant and designation of matter to be included in the record on appeal are due to be served and filed with this Court on July 21, 2014. There have been no extensions requested in this case on appeal.

A plea proceeding was held in this case on August 29, 2013, and a sentencing reconsideration hearing was held on September 9, 2013. During the sentencing reconsideration hearing, a reference was made to a proceeding held on August 26, 2013 in the case. This appears unlikely, but out of an abundance of caution, an order for such a transcript has been placed.

Our information received from trial counsel, including the notice of appeal paperwork, did not refer to August 26, 2013, as a hearing date on which a proceeding was held in the case. Nonetheless, we are requesting that the time limits be held in abeyance pending notification of the existence of or receipt of the same. A copy of our transcript request is attached.
